Sir,
In continuation of my telegram dated September 13, 1955 and the confirmatory letter No. 1019 dated 13.9.55, I am to inform you that the Vice-Chancellor in exercise of his emergency powers has been pleased to sanction recognition to your college upto the B.A. standard with effect from the current academic session, subject to the fulfilment of the following conditions :-

- (1) That a qualified Head of the department and six lecturers in accordance with the qualifications and in prescribed scales of pay are appointed.
- (2) That a part-time Art & Craft teacher and a part-time Physical Instructor is appointed.
- (3) That the building accommodation as suggested in the body of the report is provided.
- (4) That five acres of land lying vacant in the close proximity of the college be provided for play-ground and training in athletics.
- (5) That a separate hostel exclusively for the B.A. and B.Sc. students be provided.
- (6) That in addition to a recurring grant of Rs. 15,000/- per annum, a sum of Rs. 5,000/-, (spent over two years) is spent on purchase of books.
- (7) That besides a recurring expenditure of Rs. 5,000/- per annum, a sum of Rs. 7,000/- be spent on Psychology Laboratory and Science laboratory.
- (8) That a sum of 5,000/- be spent on the purchase of furniture.
- (9) That suitable provision is made for practising school within radius of one mile of the college.
- (10) That the college undertakes to meet the deficit on the opening of the proposed classes.
- (11) That not more than 50 students are admitted in the B.A. class and the teacher pupil ratio is held in maintained.
- (12) That classes be not started unless the college has fulfilled all the conditions of recognition laid down by the University and obtained the written permission of Vice-Chancellor to start such classes.

I am now to request you to let me know as to whether the conditions mentioned above are acceptable to the college authorities and if so, the manner in, and the extent to which the same have been fulfilled by the college, be communicated to this office (in triplicate) immediately.

In this connection, it may please be noted that B.Ed. classes be not started in the college unless the authorities of the college are in a position to fulfil the said conditions and to satisfy the Vice-Chancellor in regard to the fulfillment of the conditions of recognition. If you start the said class without fulfilling the conditions of recognition, the students admitted by the college will not be allowed to appear at the ensuing examination of 1961.
